CONSTITUTION OF ETHICS BOARD FOR MAINTAINING RESEARCH INTEGRITY

DEPARTMENTAL ACADEMIC INTEGRITY PANEL AND ITS FUNCTIONS

All Departments in HEI shall notify a DAIP whose composition shall be as given below:

- a. Chairman Head of the Department
- b. Member Senior academician from outside the department, to be nominated by the head of HEI.
- c. Member A person well versed with anti-plagiarism tools, to be nominated by the Head of the Department.
- The tenure of the members in respect of points 'b' and 'c' shall be two years. The quorum for the meetings shall be 2 out of 3 members (including Chairman).
- ii. The DAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff.
- iii. The DAIP shall have the power to assess the level of plagiarism and recommend penalty(ies) accordingly.
- **iv.** The DAIP after investigation shall submit its report with the recommendation on penalties to be imposed to the IAIP within a period of 45 days from the date of receipt of complaint / initiation of the proceedings.

Roles and Responsibilities of the Quorum (DAIP)

- Members should maintain the transparency and unbiased process.
- Members should ensure to investigate and give the result of judgment after considering all the criteria.
- Members must maintain the confidentiality throughout the process.
- Members must review allegations of plagiarism, objectively and without being, in detail.
- If the allegation of plagiarism is received, members should evaluate the similarity reports generated by anti-plagiarism tools for both party to check the level of plagiarism.
- Members should able to distinguish between minor and major instances of plagiarism and classify the level of plagiarism (e.g., Level 0–Level 3) as per institutional or UGC norms.
- Committee must complete the investigation process for the plagiarism give their remarks within 45 days after receiving the complaint.
- Once the committee complete the investigation, members should submit complete report which include:

- The details and nature of complain (information about both person)
- o Finding of the investigation
- o The level of plagiarism detected (If applicable)
- o If plagiarism found, the penalty(ies) recommended based of the plagiarism level
- o Any consideration needed to keep in account regarding the case

Recommendation of Penalties

If any material found plagiarised, committee should recommend appropriate penalties based on different criteria as given:

- 1. Severity of plagiarism.
- 2. Nature of the document (e.g., thesis, paper, report).
- 3. Past record of the individual (if applicable).

Committee should also ensure that the penalties are consistent within institutional policy. The committee will forward their report detail and suggested recommendation to the Institutional Academic Integrity Panel (IAIP) for further process.

INSTITUTIONAL ACADEMIC INTEGRITY PANEL (IAIP) AND ITS FUNCTIONS

HEI shall notify a IAIP whose composition shall be as given below:

- a. Chairman VC/ VC Nominee Dean/Senior Academician of the HEI.
- b. Member Senior Academician other than Chairman, to be nominated by the Head of HEI.
- c. Member One member nominated by the Head of HEI from outside the HEI
- d. Member A person well versed with anti-plagiarism tools, to be nominated by the Head of the HEI.

The Chairman of DAIP and IAIP shall not be the same. The tenure of the Committee members including Chairman shall be three years. The quorum for the meetings shall be 3 out of 4 members (including Chairman).

- The IAIP shall consider the recommendations of DAIP.
- The IAIP shall also investigate cases of plagiarism as per the provisions mentioned in these regulations.
- The IAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff of HEI.
- The IAIP shall have the power to review the recommendations of DAIP including penalties with due justification.
- The IAIP shall send the report after investigation and the recommendation on penalties to be imposed to the Head of the HEI within a period of 45 days from the date of receipt of recommendation of DAIP/complaint / initiation of the proceedings.
- The IAIP shall provide a copy of the report to the person(s) against whom inquiry report is submitted.

• Roles and Responsibilities of the Quorum (IAIP)

- The committee will review the report of investigation given by DAIP.
- If required, the committee can re-investigate the case or verify different facts provided by DAIP.
- The members of committee should communicate to both parties and check the fact without any biasness or partiality.
- The committee can decide final penalty(ies) with appropriate justification and within University/UGC policies.

Institutional Ethics Committee (IEC)

As per the University Grants Commission (UGC) Notification on Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions Regulations, 2018 dated 23rd July 2018, an Institutional Ethics Committee (IEC) is established.

The Ethics Committee is pivotal in promoting ethical conduct, ensuring integrity, and upholding the highest standards of professionalism in research and academic activities within the university.

The Ethics Committee is entrusted with the following responsibilities:

- Ensuring that all academic publications, including research papers, book chapters, etc., adhere to the guidelines specified by UGC.
- Educating and encouraging students and faculty members to maintain the highest level of academic integrity in their research and scholarly endeavors.
- Providing guidance and counseling to student and faculty members who inadvertently
 fail to comply with the guidelines and recommending appropriate actions as
 necessary.
